- 1. Organisation of the event will be carried out by management of From This Day Wedding Fair.
- 2. No contractual or other legal relationship exists between the organiser From This Day Wedding Fair or individual members and any Exhibitor.
- 3. No refund of monies will be given to the Exhibitor due to cancellation of participation at the event at any stage after approval. Should you cancel, you agree to pay all stall fees. See section on COVID-19 for further details.
- 4. Sabina River Farm and From This Day Wedding Fair staff or owners are specifically excluded, to the full extent permitted by law any liability for personal injury or loss, property damage, legal liability and financial and/or consequential loss that in any way arises from an Exhibitor's participation in the Wedding Fair or from cancellation of the Wedding Fair.
- 5. Except as stated herein, the event organisers make no representations or warranties in relation to the event.
- 6. The Exhibitor specifically acknowledges that the organiser has full discretion to refuse an application by a proposed Exhibitor to take part in the fair, or future events for any reason including but not limited to a breach of these Acknowledgements and Terms and Conditions.
- 7. From This Day Wedding Fair will not be in any way responsible for any loss suffered by an Exhibitor including but not limited to theft, fire, riot, flood, storm etc.

- 8. In the event that the Organiser has to cancel the event, they reserve the right to postpone or amend the stated dates of this Wedding Fair; the Organiser will give no less than 14 days' notice of any such postponement.

 See section on COVID-19 for further details. The event will run rain or shine, the Exhibitor will be required to make allowances for all types of weather.
- 9. The Exhibitor acknowledges that they will use their resources through social media, database or shop display to promote the event. The Organiser makes no representation as to the expected attendance or likelihood of an Exhibitor making sales or securing bookings. No responsibility will be accepted for any low levels of attendance or loss of profit to any Exhibitor.
- 10. The Organiser reserves the right to update, modify and amend these Exhibitor Acknowledgements and Terms and Conditions without notice. It is the Exhibitor's responsibility to thoroughly read and keep up-to-date with these Exhibitor Acknowledgements and Terms and Conditions.
- 11. The Organiser reserves the right in unforeseen circumstances to amend, alter or re-allocate the space or the location of an Exhibitor's designated stall site and the Exhibitor can make no objection or make no claims for compensation or damages in relation to any allocation of the size or the space reallocated by the organiser.

12. The Exhibitor must:

- Display information and merchandise that is relevant to the Exhibitor's category during the commencement and finish times of the Wedding Fair: 12:00pm and 3:00pm;
- Set up the display in the allocated time agreed between the Exhibitor and Event Organiser;
- Acknowledge that failure to complete set up by 11:30am on the morning of the event is a breach of these Terms and Conditions;
- Ensure all materials, display items, merchandise, equipment and other property of the Exhibitor remains within the designated stall site;
- Ensure that the Exhibitor's display remains set up within
 the designated stall site for the full duration of the event
 (12:00pm to 3:00pm), and dismantle the display between
 3:15pm and 5:00pm at the conclusion of the event;
- If held by the Exhibitor, provide a Certificate of Currency for public liability insurance to the Organiser;
- Ensure that there is no damage to any property of Sabina River Farm caused by the Exhibitor's display or persons working within the Exhibitor's designated stall site. The Exhibitor must indemnify and keep indemnified Sabina River Farm for any claim for personal injury, property damage, financial or consequential loss arising from the Exhibitor's participation in the fair;
- Food exhibitors must have a food license with the City of Busselton or Shire of Augusta-Margaret River to serve or sell samples of their food to guests;
- If using power, ensure that all electrical equipment complies with safety standards
- 13. Stall Sizes. If the Exhibitor's furniture and other stall items including but not limited to: signage, backdrops, personal furniture, hired furniture, lighting, personal items etc. exceed the allocated Stall Space and the Exhibitor has not gained prior approval from the Event Organisers, the Exhibitor will be required to either:
- · Remove items until the Exhibitor fits within the allocated space
- Asked to relocate their stall area to a larger space approved by the Event Organiser and pay an additional fee, due upfront

COVID-19

The organisers of From This Day Wedding Fair will follow all protocols and restrictions outlined by the Western Australian Government in the lead up to and on the day of the event to ensure the safety of all involved.

As we all know, these restrictions are subject to change with short notice. We will do all we can to ensure the event proceeds as planned. If restrictions do not allow the event to go ahead as planned we will work to re-schedule the event to the next date available post-restrictions. All stall bookings will be transferred to this date.

In the lead up to this year's event we require exhibiting vendors to put in place a contingency plan in case you are COVID positive for the event and need to isolate. This will ensure the success of the event is not compromised with vendors pulling out a week before the event. Closer to the Wedding Fair date we will contact all exhibiting vendors to request information about their representative.

We are happy for you to organise someone to set up / pack down your stall for you and to leave it unmanned on the day if you need to or if you don't have anyone to represent your business on the day.

By booking your stall you accept the following:

- Government restrictions: in the case of capacity restrictions, the event will proceed as planned if the capacity limits allow.
- If you test positive to COVID-19 and will be in isolation for the wedding fair, please advise From This Day Wedding Fair via email as soon as possible. Unfortunatley we cannot offer refunds for vendors who are unable to attend due to COVID.

We understand and appreciate the extra level of planning that is required to organise a contingency plan and we thank you in advance for helping us ensure a high quality event for our couples getting married in the South West.
